# **COMPETITION RULES**

# TITRE I - CREATION AND PURPOSE

**Article 1 :** The African Prize for Investigative Journalism - PAJI under its french acronym - is an annual award created in 2021, under the responsability of the CSO Médias & Démocratie (M&D).

**Article 2 :** The 2023 edition of APIJ/PAJI is promoted and co-organized by the following networks and platforms of panafrican journalists : M&D and the Centre d'Études des Sciences et Techniques de l'Information (CESTI) from the Cheikh Anta Diop University in Dakar, Sénégal.

**Article 3 :** The objectives of the African Prize of Investigative Journalism are the following ;

- To promote and shine the light on investigative journalism endeavours throughout the African continent, by means of an international event;
- To promote investigative journalism good practices on themes pertaining to political, administrative, economic, financial, social and cultural governance in African countries;
- To cultivate and encourage talent and excellence in investigative journalism.

**Article 4**: The African Prize for Investigative Journalism (APIJ/PAJI) honors the productions of journalists who:

- showed courage and determination in their work;
- adhered to higher journalistic standards and deontological principles.

### TITRE II - PARTICIPATION

**Article 5 :** The African Prize for Investigative Journalism (APIJ/PAJI) is open to all journalists working in Africa and exclusively on African subjects.

## Article 6: Applicants can be:

- African journalists members of the staff of a media outlet or collaborating regularly with media outlets;
- Non-African journalists working in and on Africa, who have resided on the continent for at least two years before applying;

Applications are open in the following four media categories:

- Print ;
- Web:
- Radio ;
- TV

**Article 7**: Journalistic productions shall be of good professional quality and must have been broadcasted or published by African media outlets between the 1st of january and the 31st of december of the previous year. Year 2022 is therefore the relevant period for the 2023 edition.

**Article 8 :** Applicants are requested to provide :

- Print : a PDF of the published article ;
- Web: a link to the web page of publication;
- Radio: an audio MP3 file (or link to the MP3 online);
- TV : an audio MP4 file (or link to the MP4 online).

**Article 9 :** Those productions shall be of sufficient length/volume to show the investigative aspect of the work done :

- Print : at least 6000 characters (including spaces);
- Web: at least 4000 characters (including spaces);

- Radio : at least 15 minutes ;

- TV: at least 26 minutes.

# Article 10: Applications can be submitted by :

- The journalist-author of the production, on his/her initiative;
- The media he/she works with;
- A professional organization of investigative journalists

**Article 11 :** The submissions deadline for the 2023 edition of the Prize is Wednesday 1st of march 2023 at 23h59 GMT.

The application material shall be sent to the jury at the following email address:

**Article 12:** Journalists shall submit only one production in one category, in french or english. For productions originally published in another language, a translation to french or english shall be submitted to the jury together with the original version.

**Article 13:** Duplication of a publication in order to apply to more than one category is forbidden. Any duplicated material submitted in two or more categories shall be automatically excluded from the competition.

#### Article 14: The material submitted online shall include:

- A letter from the media outlet confirming the applicant is indeed a member of/collaborating with the media who published or broadcasted his/her work.
- A CV or resume with the photography of the applicant
- A written statement from the applicant authorizing the Prize organizers to use, in the event of winning, his/her names, written material, voice, image and any other submitted material for publication, without any financial compensation, on any journalistic support, for purpose of information, publicity and PR relating to the Prize.

**Article 15**: A special commission set up by APIJ/PAJI organizers will examine each candidacy for their conformity to articles 4 to 13 before forwarding it to the jury. Any non-compliant application will be invalidated.

### TITLE III - THE JURY

Article 16: An international jury is selected each year by the organizers and designates

the winners of the African Prize for Investigative Journalism (APIJ/PAJI).

**Article 17:** The jury is composed in majority of professional journalists, as well as members of professional organizations, members of the media and of African civil society organizations, especially those involved in the defense of press freedoms. Any other individual presenting those same garantees can be selected as member of the jury.

**Article 18**: Members of the jury shall bring proof of the absence of conflict of interest when starting the process of selecting the journalistic productions. In the event of a conflict of interest, for instance if a jury member happens to be the applicant's editor or has any other relationship of hierarchical order, this judge will not participate in examining the said submission.

**Article 19 :** There is no financial compensation for the jury members. However, the organizers shall provide the jury's operating funds.

**Article 20 :** Jury deliberations are final and not subject to appeal.

### TITLE IV - PRIZES AND AWARDS

**Article 21 :** Each winner of the African Prize for Investigative Journalism shall receive a trophy, a diploma and a financial reward established as follows :

- Gold Prize, attributed to the first winner in each of the four media categories (Print, Web, Radio, TV) for an amount of 1 000 000 FCFA each;
- Silver Prize : second of each media category (Print, Web, Radio, TV) : 500,000 FCFA ;
- Bronze Prize, third of each media category: 250 000 FCFA.

**Article 22:** The jury may also decide to award special mentions and incentive prizes to other outstanding productions.

**Article 22 bis :** The General secretariate of the PAJI, in agreement with the jury, reserves the right to award only part of the 12 PAJI prizes, if quality of journalistic productions presented is deemed unsufficient.

### TITLE V: TEMPORARY AND FINAL DISPOSITIONS

**Article 23:** The organizers shall be in charge of the whole PAJI process: from call for applications to proclamation of results, as well as dealing with partnerships, organizing

workshops/debates, jury selection and awards ceremony organization.

For the logistics of collecting applications, organizers may rely on help from Press Houses, Press Centers and any other professional media structures in Africa.

**Article 24 :** The General Secretariate (formed by the three co-organizers) reserves the right to change the present set of rules, provided any modification is made public.

**Article 25:** The awards ceremony for the PAJI is organized each year in a different African capital. The 2023 edition is scheduled to take place in Dakar (Sénégal), from tuesday 25th to thursday 27th of April.
